## Slavery & Human Trafficking Statement 2020

- Introduction from the CEO of ADA Cosmetics International, Kai Boris Bendix
- We are committed to improving our practices to combat slavery and human trafficking. We have a code of ethics that focuses upon our respect for human dignity. The ADA group is present in many countries of the world, and we are committed to respecting and promoting internationally recognized standards of human rights, standards for those that work for us and are part of our supply chains and to up keeping social standards.
- We recognize the regrettable fact that many people throughout the world –
  including children are forced to work against their will and/or are subject to
  human trafficking. The ADA group does not tolerate forced or involuntary labour
  or human trafficking in any of its businesses or supply chains and particularly
  recognizes the need to keep children free from exploitation, abuse and neglect.
  The ADA group regards the use of child labour as unacceptable in any
  circumstances.

#### Due diligence processes for slavery and human trafficking

- Mitigate the risk of slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.

#### Supplier adherence to our values and ethics

We have zero tolerance to slavery and human trafficking. To ensure all those
in our supply chain and contractors comply with our values and ethics we are
working towards rigorous supply chain compliance and we work to always
improve and be better in our process and policies.





## **Training**

We aim to bring awareness with regards to slavery, servitude, forced and compulsory labour and human trafficking. The impact can be devastating for the victims. ... Increased awareness and reporting helps law enforcement to tackle the perpetrators of modern slavery as well as protecting victims.

Therefore, we commit to and ensure a high level of understanding of the risks of modern slavery and human trafficking within our supply chains and our business and will provide ongoing training to our staff.





## How are we improving?

- We will regularly review our practices and policies to ensure we have the most effective responses to prevent and remediate any negative impact on human rights and prevent all forms of Modern Slavery in our operations and supply chain.
- We are preparing key performance indicators (KPIs) to measure how effective we can
  be to ensure that slavery and human trafficking is not taking place in any part of our
  business or supply chains.
- We have set up a committee to ensure we have a Global voice within the ADA world, the committee consists of all areas that help play a part in our fight to diminish as much risk as possible. During the coming year our Committee will work towards improving our policies even further.
